

MOBILE PHONES – STUDENT USE

PURPOSE

To explain to our school community the Department's and Mount Martha Primary School's policy requirements and expectations relating to students using mobile phones and other personal mobile devices] during school hours

SCOPE

This policy applies to:

1. All students at Mount Martha Primary School and,
2. Students' personal mobile phones and smart watches. brought onto school premises during school hours, including recess and lunchtime.

DEFINITIONS

A mobile phone is a telephone with access to a cellular (telecommunication) system, with or without a physical connection to a network. "For the purpose of this policy, "mobile phone" refers to mobile phones and any device that may connect to or have a similar functionality to a mobile phone such as a smart watch.

POLICY

Mount Martha Primary School understands that students may bring a personal mobile phone to school, particularly if they are travelling independently to and from school.

At Mount Martha Primary School:

- Students who choose to bring mobile phones to school must have them switched off and securely stored during school hours
- Exceptions to this policy may be applied if certain conditions are met (see below for further information)
- When emergencies occur, parents or carers should reach their child by calling the school's office.

Personal mobile phone use

In accordance with the Department's [Mobile Phones — Student Use Policy](#) issued by the Minister for Education, personal mobile phones must not be used at Mount Martha Primary School's during school hours, including lunchtime and recess, unless an exception has been granted.

Where a student has been granted an exception, the student must use their mobile phone for the purpose for which the exception was granted, and in a safe, ethical and responsible manner.

Secure storage

Mobile phones and smart watches owned by students at Mount Martha Primary School are considered valuable items and are brought to school at the owner's (student's or parent/carer's) risk. Students are encouraged not to bring a mobile phone to school unless there is a compelling reason to do so. Please note that Mount Martha Primary School does not have accident insurance for accidental property damage or theft. Students and their parents/carers are encouraged to obtain appropriate insurance for valuable items. Refer to the Mount Martha Primary School Personal Property Policy [MMPS Website Policy Page](#) and the Department's [Claims for Property Damage and Medical Expenses policy](#).

Where students bring a mobile phone to school it, must be switched off and left in student's bags during school hours. A smart watch can be worn during school hours and used as a watch but must have all other features switched off.

Enforcement

Students who use their personal mobile phones inappropriately at Mount Martha Primary School may be issued with consequences consistent with our school's Student Engagement and Wellbeing Policy and Digital Technologies Policy [MMPS Website Policy Page](#).

In some circumstances, students' personal mobile devices may be confiscated and stored securely at the front office. In these circumstances, the mobile device will usually be returned to the student or their parent/carer at the end of the school day.

At Mount Martha Primary School inappropriate use of mobile phones is **any use during school hours**, unless an exception has been granted, and particularly use of a mobile phone:

- in any way that disrupts the learning of others
- to send inappropriate, harassing or threatening messages or phone calls
- to engage in inappropriate social media use including cyber bullying
- to capture video or images of people, including students, teachers and members of the school community without their permission
- to capture video or images in the school toilets, changing rooms, swimming pools and gyms
- during assessments

Exceptions

Exceptions to the policy:

- may be applied during school hours if certain conditions are met, specifically,
 - Health and wellbeing-related exceptions; and

- Exceptions related to managing risk when students are offsite.
 - can be granted by the Principal, or by the teacher for that class, in accordance with the Department’s [Mobile Phones — Student Use Policy](#).

The three categories of exceptions allowed under the Department’s [Mobile Phones — Student Use Policy](#) are:

1. Learning-related exceptions

Specific exception	Documentation
For specific learning activities (class-based exception)	Unit of work
For students for whom a reasonable adjustment to a learning program is needed because of a disability or learning difficulty	Individual Learning Plan, Individual Education Plan

2. Health and wellbeing-related exceptions

Specific exception	Documentation
Students with a health condition	Student Health Support Plan
Students who are Young Carers	A localised student record

3. Exceptions related to managing risk when students are offsite

Specific exception	Documentation
Travelling to and from excursions	Risk assessment planning documentation
Students on excursions and camps	Risk assessment planning documentation
When students are offsite (not on school grounds) and unsupervised with parental permission	Risk assessment planning documentation
Students with a dual enrolment or who need to undertake intercampus travel	Risk assessment planning documentation

Where an exception is granted, the student can only use the mobile phone for the purpose for which it was granted.

Camps, excursions and extracurricular activities

Students will not be allowed to bring their personal mobile device on overnight school camps or excursions. On the days of camps and excursions mobile phones are to be left at home or secured in the school office. They are not to be taken in students’ bags to these events.

Where an exception is granted, a student will be allowed to bring their personal mobile device on overnight school camps or excursions. The student can only use the mobile phone for the purpose for which it was granted.

Mount Martha Primary School's will provide students and their parents and carers with information about items that can be brought to special activities and events, including personal mobile device.

Exclusions

This policy does not apply to

- Out-of-school-hours events
- Travelling to and from school

COMMUNICATION

This policy will be communicated to our school community in the following ways:

- Available publicly on our school's website
- Included in staff induction processes and staff training
- Included in school newsletter
- Included in staff handbook/manual
- Discussed at annual staff briefings/meetings
